1. SCOPE AND TRANSMISSION OF INFORMATION

These terms and conditions apply to all contracts signed with the Global Humanistic University AI (GHU AI) and Global Humanistic University in Curacao – both referred to here together as GHU. By registering for a study program, the consumer (hereinafter referred to as the student) accepts these terms and conditions and is obliged to abide by them. By signing the enrollment form, the student agrees explicitly to all information relating to compliance and status with the GHU and its study programs. The student also agrees to email exchanges with GHU.

2. ENROLLMENT

Enrollment in a study program must be completed via the GHU website. Admission to a program can only be confirmed after an analysis of the documents submitted for the admission requirements. If all admission requirements are met, the Global Humanistic University will approve registration by means of official confirmation. The contract between the student and GHU comes into force once all the requirements are fulfilled, and the enrollment confirmation is sent. It should be noted that enrollment in a program and/or course is always binding.

3. PAYMENT

All prices indicated on the website are expressed in dollars. Tuition payment can be completed by payment form or direct debit. All documentation and material will only be sent to the student when receipt of the first payment is confirmed. Compliance with payment terms and payment dates is an essential condition for participation in the programs and graduation. GHU reserves the right to block students who fail to comply with their payment obligations. Access to documents will be withheld and there will be no further support and it will no longer be possible to apply for exams as long as payment is outstanding. Failure to comply after the first failed reminder may result in an additional annual interest of 4% on the referenced amount and legal/judicial action. When signing, the student agrees to the following procedure after the contract - see point 2. - has come into force: After the ineffective second reminder (one invoice and two reminders — and in case the second reminder is not paid within seven days) the invoice will officially be handed over to a debt collection agency. The costs incurred, up to 25% of the total price, are to be borne by the student and cannot be reduced.

4. COPYRIGHT

Remains - up until the full settlement of all payments for the products delivered (e.g. access to the online campus, documents, scripts, etc.) - of the GHU. The transfer to third parties in copy or original is forbidden.

5. REVOCATION

Cancellation/revocation of enrollment for a study program can be accomplished by the student within seven days from the date of the student's application, without giving specific reasons. To exercise this right, the student must email office@ghu.edu.ai along with a statement confirming the decision to withdraw from the relevant program. After these seven days, the student cannot cancel the enrollment and all agreed fees of the complete program must be paid in full.

6. TERMINATION CONTRACT AND ENROLLMENT

After the expiration of the right to withdraw in accordance with point 5 of these terms and conditions, the curriculum may not be terminated.

7. CURRICULUM

The study programs referenced in these terms and conditions general are the programs currently listed on the GHU homepage.



8. STUDENT CANCELLATION AND DISMISSAL

The GHU reserves the right to dismiss a student due to academic misconduct (plagiarism, repeated failure to comply with regulations, etc.). The student agrees to make an official statement regarding the information contained in all his/her documents. Incorrect information leads to an immediate cancellation of enrollment. The student is informed that all work is reviewed using software to control plagiarism. Plagiarism is a motive for cancellation. After cancellation of enrollment, remaining tuition fees must be paid in full. In the case of less severe forms of plagiarism and/or other academic misconduct, there is the possibility of a re-examination (USD 100, - / 60, -), and after several cases, an additional fee of USD 300, - will be charged for academic misconduct before registration for new exams is possible. Plagiarism may be a motive for legal action by the GHU.

In addition, the GHU reserves the right to take additional legal action in the event of cancellation of registration. If the student has already graduated, determining plagiarism at a later date will result in the student losing his degree.

9. RANGE

The range of services for the study programs is provided by the GHU and currently includes the provision of lectures and additional documents; online support; sending, receiving, and evaluation of reviews; advice for students during the program; graduation ceremonies for the students; preparing and sending certificates, academic examinations, and the final diplomas. New and additional services may be provided by the GHU and used by students. The GHU reserves the right to apply additional costs or fees to make use of the new services offered. Tuition fees do not include additional costs incurred such as PC hardware and software, legal texts, reference books, telephone costs, stamps and transmission of data and reassessment fees, and the costs of seminars and exams, which are not conducted by the GHU.

10. DUPLICATE CERTIFICATES, DIPLOMAS, AND CERTIFICATES

In principle, the certificate and the final diploma (plus a copy if the student applies for a diploma before the formal presentation during the graduation ceremony) are included in the price. If the originals are lost additional copies are USD 300, 00.

11. EXAMS

The disclosure of information (examinations, and especially examination questions) to third parties, is expressly prohibited. This constitutes serious misconduct and will be punishable by a fine corresponding to the seriousness of the offense that could go up to 5.000, - and/or cancellation of registration.

12. STUDIES

The GHU reserves the right to replace professors and lecturers and postpone the transfer of program materials within a reasonable time frame. In this case, the student does not have the right to extraordinary termination of the program (tuition cancellation), nor to the reduction of tuition fees.

13. MAXIMUM STUDY DURATION

The maximum duration for doctoral programs is seven years starting with the date of registration. All necessary examinations and work must be completed within these seven years. If the time limit is exceeded, the exclusion is automatic. There is no tuition fee refund. For other study programs, the student will find additional information on the duration on the GHU website. The GHU has the right to change the duration of programs.



14. COPYRIGHT PROTECTION

The student acknowledges that the content provided on the online platform is protected by copyright. Any duplication, dissemination, or any other use of this content beyond the student's private use is expressly prohibited and can be a motive for legal action.

15. PRIVACY

By contacting and/or registering, the interested party/student (you) accepts the processing of personal data by the provisions of the Data Protection Act for study purposes and processing exams, as well as the sending of information about job offers and/or vocational training.

You agree that the GHU and/or other companies in the GHU network, that may be of interest to you, may also use the personal information you provide (including, without limitation, name, email address, etc.) for marketing purposes to send you promotional materials or communications regarding services offered by GHU or other companies in the GHU network.

You further agree that GHU may contact you to solicit feedback on services offered within the GHU network or for market or other research purposes.

Your personal information may be shared with GHU-affiliated companies or partners worldwide in connection with sharing information within the GHU network. Please note that individual companies are autonomous and independent at the national level.

16. CHANGES TO TERMS AND CONDITIONS

Changes to the GHU terms and conditions, along with the corresponding entry in force of these, will be enacted by the publication appropriately on www.ghu.edu.ai. It is expressly stated that the decisions of the GHU are autonomous and that, regardless of whether programs or terms and conditions are affected, students do not have the right of termination and/or claim for damages in this case.

17. ADDITIONAL AGREEMENTS

Supplementary or altered agreements must be by the covenant of both parties and in written form.

18. APPLICABLE JURISDICTION AND LAW

The laws and the local jurisdiction of the courts in The Valley, Anguilla apply to all matters concerning the Global Humanistic University in Anguilla, and the laws and the local jurisdiction of the courts in Curacao apply to all matters concerning the Global Humanistic University in Curacao. The customer agrees to accept debt collection and dunning procedures in case laws and the local jurisdiction of the Anguilla courts are insufficient. The GHU is legally entitled to execute the laws and jurisdiction in its home country.

19. REGISTRATION

I have read the terms and conditions of the GHU, including the right to annulment, and I have ticked all box(es) when applicable during the application process to confirm this statement, which forms the start of my study contract and program.
